

Hockney documentary – November 2014 competition: terms and conditions

1. This competition is open to residents of the UK, Channel Islands and Isle of Man aged 18 years or more, excluding employees of the Art Fund, or anyone else connected with this promotion (or members of their families).
2. This competition is open to anyone who fills in the competition entry form with the correct answer to the following question: Where was David Hockney born?
3. The competition is open from Wednesday 12 – Tuesday 18 November 2014, 11.59pm. Entries received after this time will not be entered in the competition.
4. Only one entry per person/per email address. No third party entries, bulk entries or entries submitted by agents will be accepted.
5. As this is an online competition, it is necessary for you to have access to the internet and to have an email address. You are responsible for providing us with accurate and up-to-date contact details. We will not be liable for any failure or inability to contact you due to errors, omissions or inaccuracies in the contact details you provided.
6. The winners will be contacted by telephone and/or email within a week of the closing date. The winner will have 48 hours to accept the prize. In the event of non-acceptance within the specified period, we reserve the right to reallocate the prize and award it to the next randomly drawn, valid entry (and the same acceptance period, as provided under this condition, will apply).

The prize is two tickets to the preview screening of the [Hockney documentary including the live interview with David Hockney via satellite on Tuesday 25 November](#) at a Picturehouse cinema of their choosing and subject to availability. In the event the winner is unable to make this screening they will be allowed to transfer their tickets to a Hockney screening during general release.
